


Angolan Schools - In 2009 6 schools were funded and built. Two 20' shipping containers of donated school supplies & clothes were sent to Angola. One 40' shipping container of donated school windows and roofing for schools was sent to Angola. A 15 person team traveled to Angola to train over 250 teachers and leaders in 3 provinces and to participate in school dedications. RISE embraced a dream to impact Angola through education -- one child, one classroom, one school at a time. Since 2003, RISE has built 126 rural schools, providing the opportunity for education to over 55,000 children. RISE provides the funds for building materials. Local volunteers provide labor and See Form 990, Page 2, Part III, Line 4a (continued)

Wells - In partnership with Willow Creek Community Church's 2009 Celebration of Hope, funds were donated for wells at school sites in rural Angola. Six wells, three in the Huila Province and three in the Benguela Province are having a profound effect as children touch, splash and drink clean water for the first time! In the village of Gamba-Nongolo, after using the well for only two months, there was no more cholera nor diarrhea, and women were no longer spending hours every day making the 10km trek each way to the river. Wells at schools also allow for education about health, hygiene and the importance of clean water.
